## **Knoxville Gathering**

# The Fall 2011 meeting of the Executive Committee of the R&LHS

The meeting was held in Knoxville, Tennessee, on November 9, concurrent with the November 9-12 annual meeting of the Lexington Group in Transportation History. In addition to me, Southeast Chapter members attending some or all of the events included Paul Barnes, Joe Elliot, Lyle Key, Ed Mellon and Gordon Mott.

I attended the R&LHS Executive Committee meeting. Key among the topics discussed and actions taken at the meeting were (1) upcoming annual meetings of the Society, (2) 2012 membership renewal procedures as they impact the chapters, (3) use of "Friends" contributions for chapter-based projects, (4) a possible future relationship between the 20th Century Railroad Club and our Chicago Chapter, (5) insurance, (6) R&LHS organizational sponsorship of the Annual Conference of the Center for Railway Photography and Art, and (7) budget and membership development issues.

Tennessee Valley Railroad Museum's special dinner train on November 7 to Chickamauga, Georgia was handled by TVRM GP7 No. 1829 when former Southern Railway 2-8-0 No. 630 was temporarily sidelined with a broken spring.

No. 630 was back in service for the November 8 run over the Norfolk Southern with NS equipment to Knoxville. The 2-8-0 "Consolidation" was built in 1904 for Southern Railway freight service by the Richmond (VA) Works of the American Locomotive Company (ALCO). It was sold to the East Tennessee & Western North Carolina Railroad in 1952, becoming that road's No. 207. Southern reacquired the locomotive in 1968 for its steam excursion program, renumbering it 630. NS donated the 630 to the TVRM in 1999.



No. 203 was built by the Baldwin Locomotive Works in 1925 for the Washington & Lincolnton Railroad in Georgia. It was resold several times among shortlines in the Southeast before ending up in Knoxville in the late 1990s. Originally, a coal burning locomotive, it has been converted to an oil burner. It was restored by the G&O for the *Three Rivers Rambler* excursions.



The two trains on November 10 sponsored by the Gulf & Ohio Railroads holding company over its Knoxville & Holston River Railroad route of the Three Rivers Rambler excursions were operated with 2-8-0 Nos. 154 and 203. No. 154, seen here, was originally East Tennessee, Virginia & Georgia Railroad No. 466 built in 1890 by the Schenectady Locomotive Works (later part of ALCO). It is believed to be one of only ten preserved Schenectady-built locomotives still in existence. After the ETV&G became part of the newly formed Southern Railway in 1894, it was renumbered 154.

The Southeast Limited is published bimonthly by the Southeast Chapter of the Railway and Locomotive Historical Society P. O. Box 600544, Jacksonville, FL 32260-0544 Plans for the 2012 Annual Meeting of the Society in Birmingham May 17-20 are complete. Details and a registration form are included in the current Fall R&LHS *Quarterly Newsletter*. Planning is also underway for the 2013 meeting to be held at Madison, Wisconsin. The feasibility of Ely, Nevada as a site for the 2014 Annual Meeting is being explored, and Poughkeepsie, New York and Altoona, Pennsylvania are being considered for future meetings.

All of the chapters have agreed to the 2012 membership renewal procedure whereby national and chapter dues are submitted to the national Membership Secretary who will, in turn, remit the chapter portions to the respective chapters. To improve the timely transfer of funds to the chapters and to insure that they have funds on hand at the beginning of the year, an amount equal to 80 percent of each chapter's 2011 dues receipts will be sent by the national Treasurer by December 1, 2011, with any balance due being paid as the monies are collected.

Solicitation of contributions to "Friends of the R&LHS" will include funds for specific chapter-based projects.

In view of expressions of interest by both the 20th Century Railroad Club and our Chicago Chapter for some type of affiliation, a letter will be sent to 20th Century inviting them to consider a membership relationship with the Chicago Chapter.

It was decided that the national R&LHS would continue the recent practice of securing liability coverage for the annual meeting events. Further, an insurance committee was appointed to look into other insurance needs.

The Society will become an organizational sponsor for the Annual Conference of the Center for Railway Photography and Art.

The Society is in sound financial health with a small operating surplus expected for 2011 and projected in the 2012 budget. The 346 new members for 2011 more than offset attrition, bringing total membership to 2259. This is a reflection of the active solicitation of new members by many chapters and individuals in the Society.

Many R&LHS members are also members of the Lexington Group and took part in a full program of events sponsored by the Lexington and the Tennessee Valley Railroad Museum (TVRM) with additional participation by Norfolk Southern and Gulf & Ohio. Activities got underway Monday, November 7, when TVRM arranged charter motor coach transportation to their facilities in Chattanooga (Grand Junction) for persons arriving in Atlanta on Amtrak Train 19, the Crescent or in Knoxville. In addition to Museum events during the day, approximately forty people rode a special dinner train that evening operated by the TVRM, enjoying a superb meal and fine service en route to Chickamauga, Georgia and return. Overnight at the Chattanooga Choo Choo Hotel was followed by Tuesday's trip on Norfolk Southern to Knoxville behind the TVRM's former Southern Railway 2-8-0 No. 630.

Lexington events got underway on Wednesday with three days of interesting and informative presentations on various aspects of railroading, past and current. Included, was a talk by Southeast Chapter member Lyle Key titled "The Southland - Direct to Florida's West Coast" about one of the South's most notable and interesting passenger trains. Thursday also featured a round-trip over the Gulf & Ohio's Knoxville & Holston River Railroad to "Forks-of-the-River" involving two trains handled by 2-8-0 "Consolidations" Nos. 154 and 203 that terminated at Calhoun's Restaurant for a BBQ rib dinner. It having been previously noted that nine of the attendees had at one time or another been in a management training program of the Baltimore & Ohio Railroad, a special table was secured for this group so they could reminisce into the evening.

Norfolk Southern hosted a diesel-powered inspection trip on Saturday to Asheville/Biltmore, North Carolina and return. Sunday, an optional trip was operated behind engine No. 154 from Knoxville to Alcoa and with No. 630 on the return. Needless to say, it was a busy and enjoyable week.

There were ten members present, plus guest speaker Rudy Bartelt. It was announced that chairman John Leynes has resigned to pursue other interests.

<u>Secretary's Report</u>: Minutes from the November 10, 2011, meeting were distributed, revised to accurately reflect the future role of Cliff Vander Yacht with respect to the website and newsletter, and approved.

<u>Treasurer's Report</u>: Treasurer, Robert Van Nest reported that the Chapter has received \$941.00 from national as its "80% Advance" on 2012 Chapter member renewals.
